## EVENT REGULATIONS

"Juwenalia Gdańskie 2025".

### § 1 GENERAL PROVISIONS

1. These Regulations (hereinafter referred to as the "Regulations") regulate the rights and obligations of the participants in the Event in accordance with the principles set out in the Act of 20 March 2009 on the safety of mass events (Journal of Laws. 2009 No. 62 item 504, i.e. of 5 April 2013. Journal of Laws 2013, item 611, referred to as, the Act) and on the basis of the provisions of the Civil Code.

2. The organiser of the event "Juwenalia Gdańskie" (hereinafter referred to as the "Event") is Fundacja Gdańska with its registered office in Gdańsk, 80-830, at Długi Targ 28/29, entered in the register of associations, other social and professional organisations, foundations and independent public health care centres of the National Court Register under KRS number 0000052463, registration court - District Court Gdańsk-Północ in Gdańsk, VII Economic Division of the National Court Register, NIP 5832627491, (hereinafter referred to as the "Organiser").

3. The event takes place on 16-17 May 2025 in Gdansk, on the grounds of Zebra Square The People's Centre, 4 Giełguda Street.

4. Organizer makes the Regulations available to Participants of Event in order to acquaint them with the conditions of participation, including the rights and duties of Participants of Event, admission rules, Organizer's rights and duties, rights and duties of services (hereinafter referred to as "Service" and "Information Service") supervising the safety of Event. These Regulations also contain provisions regulating the responsibility of the Event's Participants for behaviour not complying with the Regulations.

5. These Regulations are addressed to each person present in the area where the Event takes place ("Event Venue", as defined in paragraph 8(-f) below). Each person present in the Event Venue shall abide by the provisions contained in these Regulations. The Regulations apply accordingly to persons who are not Participants, i.e., Security and Information Services, employees, Medical Service, media representatives, representatives of the Organizer and the University , etc.).

6. These Regulations are issued to ensure the safety of the Event and the transparent conditions of participation in the Event.

7. Each Participant is obliged to behave in a manner which does not jeopardise the safety of other Participants and other persons present at the Event Venue, and in particular to abide by the provisions of these Regulations and the law, as well as to obey the orders of Security Service, Information Service and the Organiser's representatives.

8. Individual words capitalized in these Regulations will be as follows relevance:





a) "Ticket" means a named (i.e., containing the name of the entitled person) identification mark confirming the right to enter the Event Venue, obtained against payment or free of charge from the Organizer or from entities acting on behalf of the Organizer. Verification of the right to enter and stay in Event Venue will take place on the basis of the Ticket entitling to enter the Event Venue on the day when the Ticket is valid, along with which the Pass or other identity document should be presented. The Ticket entitles the holder to be in the Event Venue and to participate in music concerts and other cultural events organised in the Venue, but does not entitle the holder to use any services or purchase goods available in catering or commercial facilities located in the Venue. The Organizer has provided tickets which are intended for persons wishing to participate in the Event:

- student ticket,
- normal ticket.

b) "Minor" means an Event Participant under the age 16;

c) "Identity document" means a valid official document proving the identity of the person presenting an identity card or a valid school identity card;

d) "Legitimation" is a valid document confirming the status of a student, student, doctoral student and doctoral candidate of a public or private university from the Republic of Poland or an ISIC international card.

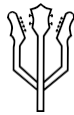
e) "Service" and "Information Service" means persons, including employees of a person or property protection agency, appointed by the Organizer to take care of the safety of the Event's Participants, including the control of the Participants' authorization to enter the Event's Area, holding identification badges placed in a visible place, containing: the name of the issuer, identification number, validity period, seal and signature of the issuer, as well as representatives of the Organizer identification badges indicating that they perform their duties on behalf of or in cooperation with the Organizer of the Event. In accordance with the act of August 22nd, 1997, on the protection of persons and property (Journal of Laws, No. 114, item 740, i.e. of July 26th, 2005, Journal of Laws, No. 145, item 1221), Security Service additionally holds a valid licence for a physical security officer.

f) "Event Venue" means the area of the People's Meeting Square in Gdańsk, 4 Giełguda Street, fenced off permanent or temporary fence on which the Event is held.

g) "Event Participant" means a person attending an Event on the basis of a Ticket presented together with the Identity Card or other proof of identity.

h) "University" means each of the following universities: Gdansk University of Technology, University of Gdansk, Gdansk Medical University, Jędrzej Śniadecki Academy of Physical Education and Sport, Stanislaw Moniuszko Academy of Music and Academy of Fine Arts.





## § 2 TICKET SALES

1. The tickets for the Event are sold by GOING spółka z ograniczoną odpowiedzialnością with its registered office in Warsaw, 116/122 Marszałkowska Street, 00-026 Warsaw, entered into the Register of Entrepreneurs by the District Court for the Capital City of Warsaw in Warsaw, XII Business Division of the National Court Register under the KRS number 0000588000, REGON: 363058596, NIP: 5272751272, share capital PLN 44,000.00. The selling prices are set by the Organiser and the price of a Ticket changes due to the sales pool. In a situation where a given pool is exhausted, the Organiser automatically switches to subsequent pools.

2. Resale of Tickets to third parties in any form, including auction or bidding is prohibited. The Organiser hereby instructs that, pursuant to the content of Article 133 of the Act of 20 May 1971, the Code of Offences (Journal of Laws No. 12, item 114, i.e. of 11 March 2013, Journal of Laws 2013, item 482) "Whoever acquires admission tickets to artistic, entertainment or sports events for the purpose of resale at a profit or whoever sells such tickets at a profit shall be subject to a penalty of arrest, restriction of freedom or a fine. Attempting as well as instigating and aiding and abetting are punishable".

3. If it is determined that a Ticket has been purchased from an unauthorised person, the Organiser reserves the right to invalidate the Ticket, which means refusal of admission to the Event.

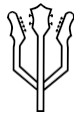
4. Holding a Ticket does not release the Participant from the obligation to pay for goods and services purchased at retail, service and catering located on the Event Venue.

5. In case an Event's Participant is a disabled person with an accompanying , the Organizers exempt the guardian from the obligation to purchase a Ticket, with the reservation that the guardian is entitled to enter the Event's Area free of charge and stay in the Event's Area exclusively in the presence of the disabled person. In order to take advantage the possibility to enter the Event Venue with an accompanying person - a carer, it is necessary to present a document confirming the disability.

6. Minors under 3 years of age are entitled to free admission to Event Venue on the basis of a Ticket issued by their legal guardian and on condition that the guardian fills in and signs a statement according to the specimen constituting Appendix no. 1 to the Regulations in the specially designated place at the entrance to Event Venue. The guardian must confirm the age of the child with any document. The guardian is fully responsible for the health and life of that person as well as for any damage caused by that person at Event Venue.

7. Minors between 3 and 16 years of age are entitled to enter Event Venue on the basis of a Ticket and in the company of an adult legal or actual guardian, holding the Ticket, - on condition that the guardian completes and signs a statement according to the model constituting Appendix 1 to the Regulations in the specially designated place at the entrance to Event Venue. The minder takes full responsibility for the health and life of that person as well as for any damage caused by that person in the Event Venue and





for the consequences of any breach by that person of the provisions of these rules or of the law universally applicable.

8. The actual guardian of a Minor can only be an adult person authorized by the legal guardian to take care of the Minor at the time and place of the Event. The actual or legal guardian may take care of a maximum of five Minors participating in the Event.

8. The Organiser does not provide concessionary or discounted Tickets for selected age groups.

9. In a situation where all Tickets have been sold, the Organiser has the right to refuse admission to a person under 3 years of age for a refund of the Ticket price made to their guardian.

11. Subject to paragraphs 5 and 6 above, a Ticket entitles only one person whose name is indicated on the Ticket to enter and remain in the Event Venue.

12. All Participants who have purchased a Ticket are obliged to keep it on the premises of the event, and to show it - together with their Legitimation Card or Identity Document - at any request of the Organiser.

13. Ascertaining the lack of a Ticket or required Pass or ID, as well as refusal to present a Ticket or Pass or ID, entitles the Organizer to demand the immediate departure from the Event Venue by the Participant, who then loses the right to stay at the Event Venue.

15. The ticket purchaser is not entitled to return the Ticket to the Organiser. The rules for returning Tickets purchased through GOING Spółka z ograniczoną odpowiedzialnością are determined by the general terms and conditions of contracts in force at this entity. In special cases justified by extraordinary life circumstances, the Organiser, in response to a documented request from the Ticket purchaser, may allow the Ticket to be returned. If the Ticket is returned, the Organiser shall refund the User the amount paid for the price of the Ticket in the amount and manner in which the purchaser paid the price for the Ticket.

16. The purchase of a Ticket is tantamount to the individual's consent to participate in the Event, on the date indicated on the Ticket, on the terms and conditions specified in the Regulations, and in accordance with the provisions of the relevant regulations or general terms and conditions of the contract on the basis of which the was purchased.

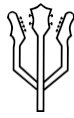
### § 3 OBLIGATIONS OF THE EVENT PARTICIPANT

1. The Event participant is obliged to:

a) to comply strictly with the provisions of these Rules;

b) to hold and present at any request of the Security Service a Ticket together with a Pass or ID document, as well as, in the event that persons under his/her care are

Minors or persons with disabilities - not with ability tickets, identification cards and identity documents of such persons.

c) comply with the instructions given by the Order Services and Information Services, and in the event of intervention by the Police, Municipal Police, State Fire Service, etc., also with their instructions.

2. Participants are Minors under 3 years of age must be accompanied at all times on the Event Venue by the legal guardian with whom they have entered. The guardian takes full responsibility for the health, life of that person.

3. During the Event, Participants agree to strictly comply with fire regulations.

## § 4 RULES OF ENTRY AND STAY IN THE EVENT AREA

1. Admission to the Event Venue is granted upon presentation of a Ticket together with a valid ID. A minor and guardian of a disabled person may participate in Event on condition that the minor's legal or actual guardian submits the statement specified in the Appendix no. 1.

3. Participants of the Event and all persons in the Event Venue required to have:

a) Ticket;

b) Identity document or ID ;

4. The absence of any of the listed entry documents is unequivocal grounds for the removal of the Participant from the Event Venue.

5. The Participant who leaves the Event Venue during the Event will not be entitled to return to the Event Venue on the basis of the previously presented Ticket. Re-entering the Event Venue after leaving the Event Venue will require another purchase of the Ticket.

6. A zone will be set aside at the Event Venue for the sale of alcoholic beverages with an alcohol content of more than 3.5%. Consumption of alcoholic beverages purchased in this zone, including alcoholic beverages with an alcohol content not exceeding 3.5%, will only be possible within the boundaries of this zone.

## § 5 LIMITATIONS ON PARTICIPATION

1. In addition to the conditions described in the paragraphs above, the Organiser is obliged to refuse entry to the Event Venue and to demand that the Event Venue be vacated by:

a) persons under the influence of alcohol, intoxicants, psychotropic substances or other similarly acting agents;





b) persons behaving provocatively, aggressively or posing a real threat to public order or security;

c) persons whose dress makes identification impossible;

d) persons in possession of weapons or other similarly dangerous objects, explosives, fire hazardous materials, pyrotechnic materials, alcoholic beverages, narcotics, psychotropic substances or other dangerous objects posing a threat to Event Participants. The decision to classify an object (or material) as dangerous is made by the Security Service and representatives of the Organiser;

e) persons who refuse to submit to the activities of the Order and the Service Information;

f) persons with glass and metal packaging, containers and cans;

g) persons staying at the Event Venue with animals;

h) persons against whom a decision has been issued banning them from entering a mass event or obliging them to refrain from being present in places where mass events are held

[PM1]k) persons bringing animals into the Event Venue, excluding dogs assisting persons with disabilities.

2. In addition, it is prohibited for Participants to bring into the Event Venue:

a) alcoholic beverages, narcotic drugs, psychotropic substances or other similarly acting agents, and food and non-alcoholic beverages.

b) Weapons of any kind, explosives, pyrotechnics (e.g. firecrackers, firecrackers, flares, torches), fire hazardous materials or other similarly dangerous objects that can endanger human life or health, e.g. baseball bats, metal pipes, knives, long-handled umbrellas, etc;

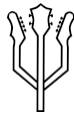
c) glass, plastic and metal containers and cans. The Security Service may condition the admission to the Event Venue on leaving such an item outside the area where the Event is taking place. The above restriction does not apply to food and beverages purchased by Participants in the catering area in the Event Venue.

3. The Organiser has commissioned the operation of a depository located at the designated gate of items prohibited under these Regulations to be brought in and possessed during the Event. The depository is payable and is governed by separate regulations and price list.

4. In addition, the following is prohibited on the Event Site:

a) destroying or damaging elements of the site equipment, festival decoration and any property belonging to other Participants or persons (entities) providing services at the Event site;





b) bringing in musical instruments or other devices that may cause a disturbance to the Event or its smooth running;

c) Bringing in banners, posters, emblems or other materials not related to the Event;

d) bringing in cameras or other audio/video recording equipment;

e) recording of stage performances by means of camera, telephone or other electronic devices and distribution of the material thus recorded by any technique.

5. Apart from entities expressly authorised by the Organiser or the Co-organiser, it is strictly forbidden to carry out, at Event Venue, any business or profit-making activity not related to the Organiser or the Co-organiser and, moreover, any promotional or advertising activity. It is forbidden to carry out, at Event Venue, any fundraising, fundraising or signature collection. In case of violation of the above mentioned prohibition, the Organizer reserves the right to take legal action.

6. The Organizer reserves the right to inspect the clothing and luggage of persons entering the Event Venue. Persons who refuse to undergo this activity will not be allowed to enter the Event Venue.

7. In case the content of the inspected luggage or clothing contains items which it is forbidden to bring and possess in the Event Venue, a Security Service employee refuses to let the person who was found to be in possession of these items enter the Event Venue and, in the possession of these items is found after entering the Event Venue, removes the person from the Event Venue.

8. Persons refused entry to or stay in the Event Venue, or persons removed from the Event Venue in accordance with the Regulations or the Act for breach of the Regulations or the Act, shall not be entitled to a refund of the Ticket.

## § 6 SECURITY AND ORDER DURING THE EVENT

1. In order to ensure safety and order during the Event, the Organizer appoints Security Service, Information Service and Medical Service. Participants are obliged to comply with all instructions given by the designated services, under pain of removing the Participant from the Event Venue.

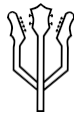
2. Representatives of the Organiser, as well as Order and Information Services bearing a badge displayed in a visible place, are entitled to:

a) to check the entitlement to be present at the Event Venue;

b) legitimisation of Minors;







c) to inspect the contents of clothing, luggage and other items in order to verify the absence of items prohibited under these Regulations from being brought into the Event Venue;

d) give orders to Participants behaving in an aggressive or provocative manner, disturbing public order and order or violating the provisions of the Act or the Regulations, and if they do not comply with the order - order them to leave the Event Venue. The refusal to comply with these orders may result only from their contradiction with the generally applicable provisions of the law.

e) the use of physical force in the form of incapacitating holds and similar defence techniques in a situation of threat to goods or repelling an attack on a member of the Order Services or another person under the terms of Article 38 the Act of 22 August 1997 on the Protection of Persons and Property.

f) to apprehend, for the purpose of immediate handover to the Police, persons posing a threat to human life or health, as well as to property, and in the event of possession by the Participant of prohibited narcotic and psychotropic drugs.

3. Orderly Service personnel may be equipped to ensure security

w:

a) Ticket designs;

b) metal detectors;

c) other necessary personal protective equipment.

4. The organiser shall ensure fire safety by ensuring familiarity by the Fire Service:

a) the location of fire-fighting equipment and the rules of conduct in the event of a fire;

b) the principles of evacuation, the use of hand-held firefighting equipment and the provision of medical first aid.

5. If a Participant notices a fire or any other situation posing a threat to persons or property at the Event Venue, he/she is obliged to immediately inform the Security Service and Information Service.

6. The Organiser does not provide parking. There are public, paid, unguarded car parks in the area adjacent to the Event Venue. The Organiser is not responsible for parked cars and the conditions of such parking in areas belonging to other entities.

## § 7 AUTHORITY OF THE ORGANISER

1. The Organizer informs that he is authorized to record the proceedings of the Event and the images of the Participants, both in terms of sound and images. The material recorded during the Event which may be used as evidence to initiate criminal or misdemeanour proceedings, will be immediately handed over by the Organizer to the District Prosecutor appropriate for the place of the Event or to the relevant Police Commander. Fixed







during the course of the Event, materials that do not allow proceedings to be initiated are kept by the Organiser for a period of 30 days after the end of the Event.

2. The Organiser also records the Event for documentation purposes, promotion and advertising of the Event and events in future years. The image of the persons captured on the recording may be disseminated by the Organiser for the purpose of advertising and promoting the Event, as well as for documentary and reporting purposes. The Participant declares that he/she will not make any claims to the Organizer due to the use of his/her image in the advertising, promotional and press materials reporting the course of the Event.

3. In the event of disturbing public order and public nuisance, as well as in the event of the Act or the Rules, the Organiser may call upon the Participant to behave appropriately, and in the event of further violation of the rules of participation in the Event, call upon Participant to leave the Event Venue and use all available means to enforce the above request.

4. The organiser is not responsible for any items left on the Site Events.

5. The Participant shall be fully responsible for any damage caused by him/her on the Event Venue to other Participants, as well as for damage caused to the Organiser's property.

#### § 8 COMPLAINTS

1. Complaints related to the course of the Event should be submitted within 14 days after the end of the Event to the Organizer's address: Gdańsk Foundation with its registered office in Gdańsk, 80-830, Długi Targ Street 28/29 with the annotation "Juwenalia Gdańskie". Address for correspondence: 10 Rycerska Street, 80-882 Gdańsk.

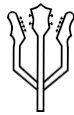
2. The organiser shall examine and respond to complaints within 21 days of their receipt To the Organiser by registered mail.

3. The condition for the assertion of claims is the use of the complaints procedure referred to in in this chapter of the Rules of Procedure.

#### § 9 PERSONAL DATA, RIGHT OF IMAGE

1. The administrator of the personal data contained in the declarations referred to in §2 sections 6 and 7, drawn up on the basis of Appendix no. 1, is Fundacja Gdańska (Gdańsk Foundation) with its registered office in Gdańsk, ul. Długi Targ 28/29, entered into the register of associations, other social and professional organisations, foundations and independent public health care centres by the District Court Gdańsk-Północ in Gdańsk, VII Economic Division of the National Court Register under KRS number: 52463, NIP: 5832627491. The personal data are processed in order to verify the Participants of the Event. Providing the personal data specified in Appendix no. 1 is





voluntary, with the that refusal to provide such data will result in refusal of admission to the Event for the Minor or the guardian of the person with a disability, respectively. The legal basis for the processing of personal data is that it is necessary for the purposes of the administrator's legitimate interests in controlling admission to the Event Venue.

2. The administrator of the personal data provided when purchasing a Ticket is GOING spółka z ograniczoną odpowiedzialnością with its registered office in Warsaw, 116/122 Marszałkowska Street, 00-026 Warsaw, entered into the register of entrepreneurs by the District Court for the Capital City of Warsaw in Warsaw, XII Economic Division of the National Court Register under the KRS number 0000588000, REGON: 363058596, NIP: 5272751272, share capital of 44,000.00 PLN, under the terms and conditions available on the sales website.

3. By purchasing a Ticket, the Participant agrees for their image to be recorded in the form of video and photographic images, as well as for the Organizer and the University to use their image recorded in this way for the purposes related to the Organizer's and the University's statutory activity, and also to promote this activity and promote future editions of the Event by reproducing, copying, multiplying, displaying, presenting and publishing it in any technique and form, in any medium and in any number of copies. The purchase of a Ticket for a Minor and for a Participant between the ages of 16 and 18 will be tantamount to consent by their legal guardian to the use of their image on the conditions specified above.

## § 10 CRIMINAL PROVISIONS ARISING FROM STATUTES

1. Art. 54 (1) of the Act: Whoever fails to carry out an orderly order issued under the Act or the Regulations by the Organiser or the Orderly or Information Services shall be punished with arrest, restriction of liberty or a fine of not less than PLN 2,000. The same penalty shall be imposed on anyone who, during:

a) mass event is in a place not intended for the public;

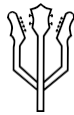
b) of a mass sports event stays in a sector other than the one indicated on the admission ticket or other document entitling to stay at the mass event and does not leave that sector despite being summoned by an authorised person.

2. Article 55 of the Act: Whoever disobeys an order issued by the Police or the Military Police, at the place and during the duration of a mass event, shall be subject to the penalty of restriction of liberty or a fine of not less than PLN 2,000.

3. Article 56 of the Act: Whoever, contrary to the provisions of the Act, brings or possesses drinks at a mass event alcoholic beverages, shall be subject to a penalty of restriction of liberty or a fine of not less than PLN 2,000.

4. Article 57a. Whoever, at the place and during a mass sports event, uses an item of clothing or an object in order to prevent or significantly impede the recognition of a person, shall be subject to the penalty of restriction of liberty or a fine of not less than PLN 2000.



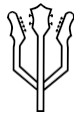


5. Article 59. 1. Whoever brings or possesses at a mass event weapons, within the meaning of the Act of 21 May 1999 on Weapons and Ammunition (Journal of Laws of 2004 No 52, item 525, as amended), pyrotechnic products, fire hazardous materials or other dangerous objects or explosives, shall be subject to a fine of not less than 180 daily rates, the penalty of restriction of liberty or the penalty of deprivation of liberty for a period from 3 months to 5 years.

#### § 11 FINAL PROVISIONS

1. The Organizer informs that the Participant of the Event may be exposed to sounds which may adversely affect the hearing centre. In addition, during the Event, Participants may be in the zone of strong lighting, including the action of strobe lights. Pregnant women and epileptic patients, in particular, are at particular risk due to the use of the above mentioned technologies by the Organizer. By entering the Event, participants acknowledge the above and participate in the Event at their own risk. The organiser is not responsible for any damage to the participants' health.
2. All rights to the name and logo of the Event are reserved to the Organiser.
3. The Organiser reserves the right to change the date and times of the Event or to cancel Event due to organisational or infrastructure changes or changes beyond the Organiser's control (e.g. bad weather conditions).
4. The organiser reserves the right to change the course of the Event for unforeseen reasons, e.g. equipment failure or cancellation of the artist, as well as for reasons caused by weather conditions - without prior compensation.
5. In matters not covered by the Regulations, the provisions of the Act and the Code of civil.
6. The purchase of a Ticket is tantamount to the Participant's acceptance of these Terms and Conditions.
7. The regulations are available on the Organiser's [www.juwenaliagdanskie.pl](http://www.juwenaliagdanskie.pl) website
8. The Rules of Procedure shall enter into force on the date of their promulgation.
9. The organiser has the right to amend the Rules and Regulations with regard to safety and the improvement of conditions for participants, as well as to the extent required by general and local law.
10. The Organiser does not have the right to change the Regulations with regard to: terms and conditions of ticket purchase, complaints, definition of persons authorised to enter the Event Venue and rules of participation in the event for minors and persons with disabilities.

By entering the Event, Participants acknowledge the above and participate in the Event at their own risk.
